4. Parks and Recreation

a. Monthly Report, Debbie Dennis Superintendent of Recreation, they are aiming to get at least the same number of fish as last year. Half will go on the first Friday, the other half the second Friday.

5. Parks & Grounds

- a. Monthly Report, Steve Wood, Superintendent of Parks & Grounds, ice storms and snowstorms they were supporting and keeping everyone safe. Zippadelli and Sage one are completely locked up and have a chain as well. There are cameras in this area.
- b. Percival Field, Jen Ochoa, Director of Community, Recreation and Park Services, reached out to the contractor asking when they would want to begin for the season now that the snow has melted. The town attorney and architect are involved in these emails and there has been no response yet. The contractor has to fix a few things, and there needs to be a surveyor to check on the contractor's work involving the pitch. They will make sure that field is usable in the spring.
- c. Demore, Dinda, Bittner Jr. Memorial Pool Complex, Steve Wood, Superintendent of Parks & Grounds, the committee was in favor of the project and that it was a reasonable price and within range. Jen Ochoa and Steve Wood would need to create a statement of needs for the complex. They are planning to present at the April Town Council meeting. The M ayor has stated that he is in favor of funding a splash pad. They do want to expand that parking lot another 15 or so spots because they will eventually run into an issue with parking once the splash pad is installed. Commissioner Bovee is concerned that the operating budgets have been passed this week. This project would be close to being bonded, there is concern that it might not end up part of the budget in April. Any projects that are over 25k they have to get quotes and are being funded to do more feasibility studies so there are no surprises in the future. If everyone is in favor they are hoping to pass it during July. Commissioner Bovee had a few suggested changes to the Statement of Needs before submission.

The Community Senior Center was discussed, the Town Council leadership misportrayed the process of choosing the town property as something the Parks and Recreation decided.
